•It is important to keep an accurate and up-to-date record on each horse. The records should be complete and organized in such a way that someone else could take care of your horse if the need should arise. Each record book is designed to allow for a years worth of records. On the cover are the start and end dates of each book so that they can be easily filed in chronological order. The records (or a copy of the records) should stay with the horse even if the horse is sold or leased. The record book provided by USPC is just one way in which records on a horse can be kept. Any method of record keeping that is convenient and includes all of the enclosed information is acceptable. The important thing is to use a system that works for you.

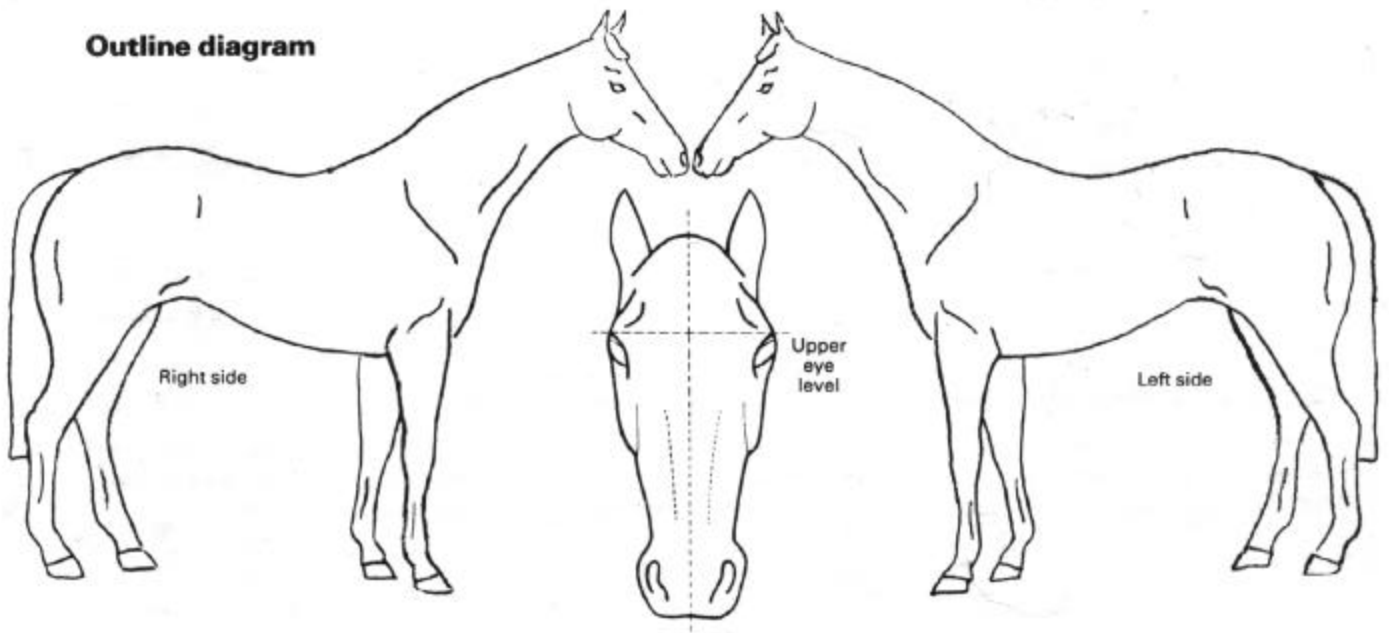

- The sire and dam information can be found on most breed registry papers. The sire is referred to as "by" and the dam is referred to as "out of". Often the sire of the dam will also be listed. If the horse does not have papers or the bloodlines are unknown, write unknown in the spaces.
- When listing the horse's weight, make sure to list the units (lbs. or kg.).

•Worming medications may be selective in their action and may need to be rotated to be effective. The necessity to vaccinate against specific diseases may vary from one location to another. Ask your veterinarian which dewormers and vaccinations are most appropriate for your horse and your area.

•When presenting your record book at a rating, or if you wish to keep a running total as the year progresses, be sure to write the totals in pencil. At the end of the year, when the record book is completed, the totals can be written in pen.

•Note the two separate entries for immunizations given on 4/1/00. They are listed this way because the due date for the next flu, rhino immunization is different than the next due date for the tetanus, EEE, WEE immunization.

•At the B level and above brand name and lot number for vaccinations should be indicated.

•At the B level and above brand name as well as drug name should be used with worming medication.

- Make sure to note the units (i.e. lbs., oz., etc.) by which you are measuring all the different feeds and supplements.
- As feeds all weigh different amounts, it is important to measure in weight and not volume. For example a scoop of bran would weigh much less than a scoop of corn.
- It is a good idea to know approximately how much a flake of hay weighs as your idea of a flake may be different than someone else's idea of a flake.
- The current feed schedule and changes should be posted in the feed room as well as on the horses stall.

- When doing conditioning work, it is important to keep records on the horse's temperature, pulse and respiration rates' after strenuous work. This, along with the recovery rate will help to determine the condition of the horse.
- This page can be used in correlation with the feeding page. Changes to the conditioning schedule will often coincide with changes to the feeding schedule.
